For the most part, this 12-minute video highlights the problems, and most people with common sense would agree with its message. Another topic that is introduced today is Chain Migration, which refers to the endless chains of foreign nationals who are allowed to immigrate to the United States because citizens and lawful permanent residents are allowed to sponsor their non-nuclear family members.

It demonstrates media bias when you see any national media coverage of immigration purport their opinion, yet, fail to recommend the well documented research provided by the Immigration Gumballs video referenced above. It is of growing importance that grassroots citizens engage themselves in many public and political "issues" with a research background of such topics, in order to discern when mainstream media is bias. Unless, YOU gather your own research, the media "opinion" is accepted by the general public and the true discernment mislead by the media. We must engage the public to the importance of our own research of our politicians and media.

Chain Migration is the primary mechanism that has caused legal immigration in the U.S. to quadruple from about 250,000 per year in the 1950s and 1960s to more than 1 million annually since 1990. As such, it is one of the chief culprits in America's current record-breaking population boom and all the attendant sprawl, congestion, and school overcrowding that damage Americans' quality of life, and costs throughout the system with an average immigrant being a laborer rather than a scientist or engineer, which America is in desperate need of such highly educated immigrants. We must improve this immigrant population. This is the reason so many of our manufactures are establishing production facilities offshore, because they aren't available in the U.S.

After World War II, America experienced another large by immigrants of Christians, Jews (who were persecuted and most from Communist countries with dictatorships) which basically outlawed free enterprise. They immigrated to the U.S. offering freedom, and as part of their immigration testing, they were required to "study" our U.S. Constitution to understand these freedoms. However, many people today, VOTE on the basis of their political party only, and NOT on the basis of the candidates as <u>qualified representatives</u>. The quality of our political candidates is diminishing as a result of ill-informed voters who now outnumber a voting population who take the ability to evaluate and vet a candidate based on his/her experience and political integrity. Gridlock is a result of stubborn personal positioning (on either side) rather than logic, common sense and deductive reasoning. Terminating ANY discussion at this stage will never result in forward progress. Juries, judges, arbitrators, counselors are all commissioned with resolving "differences" and ALL applications REQUIRE communication.

I hate to be redundant, but, I have to go back to my original dialogue, conservative is an original recommendation in the bible. The heavy lift is to help a liberal mindset "recognize" the original intent of conservative principals rather than a "political position." The misrepresentation of these terms is the reason for the steadfast opposition between them, not the actual meaning of the words. Again, "I have to be conservative with my salt because it is a danger to my health", therefore, I will use very little. People with a conservative mindset have to take on the challenge of inviting the liberal mindset to an open dialogue about each position. Neither position should object to this as being education.


The United States had no designated refugee policy during the Nazi period. It only had an immigration policy. Those escaping Nazi persecution had to navigate a deliberate and slow immigration process. Strict quotas limited the number of people who could immigrate each year.

Potential immigrants had to apply for one of the slots designated for their country of birth, not their country of citizenship. After Great Britain, Germany had the second highest allocation of visas: 25,957 (27,370, after Roosevelt merged the German and Austrian quotas. The total allowed was approximately 153,000.


Though at least 110,000 Jewish refugees escaped to the United States from Nazi-occupied territory between 1933 and 1941, hundreds of thousands more applied to immigrate and were unsuccessful.
